1 Stephen N. Bartulica was elected member of the Croatian Parliament in 2020. He is an associate professor of political philosophy at the Catholic University of Croatia in Zagreb. His scholarly interests include the relationship between religion and politics, ideologies and constitutional theory. He is the founder and president of the Center for Renewal of Culture, a Croatian think-tank dedicated to educating young professionals in virtue ethics and leadership. The Center was part of a coalition which successfully organized a national referendum on defining marriage in 2013. Before his career in academia and politics he served as a diplomat for 12 years. Mr. Bartulica is a native of St. Joseph, Missouri.

2 Damir Biloglav was born on February 19, 1960. in Zadar, where he attended primary and secondary school. He studied at the medical faculty University in Zagreb and obtained the title of doctor of family medicine. He is a volunteer of the Homeland War in which he was an Officer of the Croatian Army and Commander of the 112th Brigade of the Croatian Army in 1991-1992. that year was the first doctor in the liberated areas of Lika in August 1995. In several mandates, he held the position of president of several associations of doctors from PZZ (primary health care), was also chosen as the Best five times doctors according to patients' experiences. He is the president of the Zadar County branch of the Homeland Movement, councilor of the Homeland Movement in the City Council of the City of Zadar and a member Presidency of the Homeland Movement.
