We started as a vehicle expert office and have grown very successfully. Over time, special appraisals were added due to the extensive expertise. In addition, we have now established a Europe-wide network of experts and appraisers within this year and have built up the specialist areas of environmental, energy and occupational safety, as well as medicine, occupational medicine and law.

Our neutral expert opinions serve as a basis for the enforcement of your claims against the insurance company or your own insurance company. The expert services can be used by private persons, insurances, courts, lawyers, leasing companies, commercial and industrial enterprises, among others.

At 21.10.2020 at the Georg Büchner Gymnasium (School) in Darmstadt (Germany) of the principal an expert team, consisting of an attorney, a safety engineer as well as a physician was rejected and not heard. This team wanted to point to the deficits in the industrial safety as well as to the wrong application of the partly not certified masks and to show the correct application of masks. The school politicized this topic and did not take it seriously. The team was expelled from the school. This incident has also happened in other schools. Here the school management has carelessly endangered the health of their students and teachers. Besides the politics inclusive the police then played down these cases.

Particularly in Darmstadt at 29.10.2020 at above mentioned school, a girl received emergency medical treatment because of breathing difficulties. In the eyes of the team of experts, this will very often be the case in the future.

On October 24, 2020, the expert reported the principal to the criminal investigation department and the public prosecutor's office in Darmstadt for his negligent actions. There was no reaction. To date, the expert has not been heard on the matter either by telephone or in writing. It is highly probable that the emergency physician's intervention is due to the deficits revealed by the expert investigator. We ask the parents of the child to contact the expert or a doctor who will contact the team of experts to clarify the situation.

In addition, we call for the closure of all schools throughout Germany until the occupational health and safety regulations that were in force until January 2020 are put in place. Attempts have also been made politically, including in the media (ARD, there are fact-checker documents available here that tend to play down this issue), to suspend all these regulations. Anyone who, like this principal, treats the health of his students (protégées) and his teachers carelessly will be charged.

We immediately call upon all parents and teachers, who feel that they themselves have been instructed incorrectly about the use of the mask, the prescribed mask break times, the control of the mask break times, the symptoms of CO₂ poisoning, the immediate measures to be taken in case of CO₂ poisoning, to immediately file a criminal complaint, because this means a health hazard for themselves, the instructed staff and children. Furthermore, we call upon every employer who does not comply or who has not. Since the team of experts is not able to do this on its own, the team of lawyers and experts will work together to bring this about, because at least gross negligence is involved. Furthermore, all responsible directors and chief editors in Germany, who have carried out harmless reporting, will be brought to justice. Furthermore, all editors and so-called fact-checkers who want to contain a pandemic and do not pursue objective reporting, also with regard to occupational safety and health protection of the entire population, will apply for criminal prosecution. However, we hope that the population, the doctors, will come to their senses. The medical profession is aware of the facts, but does not act, or acts with gross negligence and fears for their medical license. They thus accept the health hazard up to the death of individual members of the population. Criminal charges are brought against all heads of medical institutions and all practicing doctors who fail to implement the requirements of the G 26 investigation and its legal regulations and to point out the dangers.

It is also to be pointed out, that self-made masks are accompanied by far more dangers for the health, since these are highly irregular, most even highly critical. Here the wearing duration must be evaluated even more critically than medical masks. It should also be pointed out that these masks are basically disposable masks which can have fiber breaks after repeated use and can be re-inhaled into the

lungs. The protection promised to the population by the media and political decision-makers has not been professionally proven and guaranteed. Therefore, the masks are not only useless, but also highly dangerous if they are improperly handled and the associated protective regulations are not complied with. Layman masks can pose a health hazard (this has been known and defined for years from the accident prevention regulations and the guidelines of the employers' liability insurance associations). On the basis of these findings, criminal charges are filed, as these are active health hazards as well as grossly negligent and intentional health hazards. If a teacher or principal treats his students so carelessly in spite of this knowledge, or an employer, in spite of the knowledge of the liability of the employer's liability insurance association, forces his employees to wear a mouth-nose cover during working hours, he must deal with the legal consequences and must bear them. I would like to ask all judges and public prosecutors' offices, as well as professional associations whose employees fall within the scope of their insurance coverage during working hours, to start their investigations.

We hereby hope that the discussion on this topic will get underway. We, the team of experts and appraisers, will be available at any time for interviews and objective statements, which can also be presented in dialogue. We ask you to refrain from one-on-one interviews, as these are unfortunately of no further use in Germany. We, the entire team of experts, have been busy for several weeks now clarifying the facts and disseminating the information. Unfortunately, these facts are currently ignored by all responsible authorities, some even dismissed as a conspiracy theory and health protection is played down.

It is pointed out that anyone who writes this article in a modification that does not correspond to the original will be held accountable. Those responsible must be named at all times via the appropriate media.

We ask every reader to check for himself/herself to what extent he/she or his/her children or even parents are affected by these restrictions, in order to possibly take legal action against them.
